**Application:** This kit is designed for the quantitative determination of Angiopoietin-like 4 (ANGPTL4) in

serum, buffered solution or cell culture medium using a homogeneous AlphaLISA assay (no wash steps). The assay shows no cross-reactivity with Angiopoietin 1, Angiopoietin 2 and

Angiopoietin-like 3. Cross-reactivity with other species was not tested.

Kit contents: The kit contains 5 components: AlphaLISA Acceptor beads coated with Anti-ANGPTL4 antibody,

Streptavidin-coated Donor beads, Biotinylated Anti-ANGPTL4 antibody, Lyophilized Human

ANGPTL4, and 10X AlphaLISA Immunoassay Buffer.

Sensitivity: Lower Detection Limit (LDL): 25.77 pg/mL

Lower Limit of Quantification (LLOQ): 112.29 pg/mL

**Dynamic Range:** 25.77 – 3,000 000 pg/mL

Storage: Store kit in the dark at +4°C. For reconstituted analyte aliquot and store at -20°C.

**Stability:** This kit is stable for at least 12 months from the manufacturing date when stored in its original

packaging and the recommended storage conditions.

Lot to lot consistency is confirmed in an AlphaLISA assay. Maximum and minimum signals,  $EC_{50}$  and LDL were measured on the EnVision Multilabel Plate Reader with Alpha option. We certify that these results meet our quality release criteria. Maximum counts may vary between bead lots and the instrument used, with no impact on LDL measurement.
