a homogeneous AlphaLISA assay (no wash steps). This assay can facilitate the design and

development of antibody therapetics by using competitive binding to PD-1/P-L1.

Kit contents: The kit contains 5 components: anti-6xHis AlphaLISA Acceptor beads, Streptavidin-coated

Donor beads, Biotinylated human PD-1, His tagged human PD-L1 and AlphaLISA Immunoassay

buffer.

Storage: The kit components must be stored at +4 C and in the dark for the beads.

Stability: This kit is stable for at least 6 months from the manufacturing date when stored in its original

packaging and the recommended storage conditions.
