Application: This kit is designed for the quantitative determination of mouse IgG in cell culture/non-mouse

serum, using a homogeneous AlphaLISA assay (no wash steps). The assay shows negligible

cross-reactivity with other mouse Igs.

Kit contents: The kit contains 5 components: AlphaLISA Anti- mouse IgG Acceptor beads, Streptavidin-coated

Donor beads, Biotinylated Anti- mouse IgG Antibody, Lyophilized mouse IgG and 10X AlphaLISA

Immunoassay Buffer.

Stability: This kit is stable for at least 6 months from the manufacturing date when stored in its original

packaging and the recommended storage conditions. Note: Once reconstituted, the mouse IgG

analyte is stable for at least 18 months when stored at -20°C.

Lot to lot consistency is confirmed in an AlphaLISA assay. Maximum and minimum signals, EC₅₀ and LDL were measured on the EnVision Multilabel Plate Reader with Alpha option. We certify that these results meet our quality release criteria. Maximum counts may vary between bead lots and the instrument used, with no impact on LDL measurement.
