

**STABILITY AND STORAGE RECOMMENDATIONS:** When deoxy-D-glucose,  $2-[1-^{14}C]$ - is stored at 5°C in its original solvent and at its original concentration, the rate of decomposition is initially 2% per year from date of purification. Stability is nonlinear and not correlated to isotope half-life. Lot to lot variation may occur.

SPECIFIC ACTIVITY RANGE: 45-60 mCi/mmol (1665-2220 MBq/mmol)

**RADIOCHEMICAL PURITY:** This product was initially found to be greater than 97% when determined by the following method. It is advisable to check purity prior to use:

High pressure liquid chromatography on a Aminex HPX-87C column at 80°C using the following solvent system:

Water

Paper chromatography on Whatman No. 1 using the following solvent system:

a. n-butanol: ethanol: water, (50:32:18).

b. n-butanol: acetic acid: water, (4:1:5).

c. n-butanol : pyridine : water, (6:4:3).

**QUALITY CONTROL:** The radiochemical purity of deoxy-D-glucose,  $2-[1-^{14}C]$ - is checked at appropriate intervals using the HPLC method.
