PACKAGING: 1.0 mCi/ml (37 MBq/ml) in ethanol: water (1:9), under argon, in a silanized vial. Shipped in dry ice.

STABILITY AND STORAGE RECOMMENDATIONS: The stability of CGP 39653, [propyl-2,3-3H]- is currently being evaluated. Initial studies indicate that when CGP 39653, [propyl-2,3-3H]- is stored at -20°C in its original solvent and at its original concentration, the rate of decomposition is initially 1-2% per month from date of purification. Lot to lot variation may occur.

SPECIFIC ACTIVITY RANGE: 20-50 Ci/mmol (740-1850 GBq/mmol)

RADIOCHEMICAL PURITY: This product was initially found to be greater than 97% when determined by the following method. The rate of decomposition can accelerate. It is advisable to check purity prior to use:

High pressure liquid chromatography on a NH_2 column using the following mobile phase: Potassium diphosphate, pH3.0.

QUALITY CONTROL: The radiochemical purity of CGP 39653, [propyl-2,3-3H]- is checked at appropriate intervals using the above listed chromatography method.
