PACKAGING: 1.0 mCi/ml (37 MBq/ml) in ethanol: water (2:98) stored under argon. Shipped in blue ice.

**STABILITY AND STORAGE RECOMMENDATIONS:** The stability of phenylalanine, L-[2,3,4,5,6- $^3H]$ - is currently being evaluated. Initial studies indicate that when phenylalanine, L-[2,3,4,5,6- $^3H]$ - is stored at 5°C in its original solvent and at its original concentration, the rate of decomposition is initially 3.5% per month from date of purification. Stability is nonlinear and not correlated to isotope half-life. Lot to lot variation may occur.

SPECIFIC ACTIVITY RANGE: >70 Ci/mmol (2590 GBq/mmol)

**RADIOCHEMICAL PURITY:** This product was initially found to be greater than 97% when determined by the following method. The rate of decomposition can accelerate. It is advisable to check purity prior to use:

High pressure liquid chromatography on a SCX column using the following mobile phase: 0.02M potassium phosphate, pH 3.0

**QUALITY CONTROL:** The radiochemical purity of phenylalanine, L-[2,3,4,5,6-3H]- is checked at appropriate intervals using the listed chromatography method.
