PACKAGING: 0.1 mCi/ml (3.7 MBq/ml) in 0.1N acetic acid : ethanol (8:2). Shipped in dry ice.

**STABILITY AND STORAGE RECOMMENDATIONS:** When nociceptin, [leucyl-3,4,5-<sup>3</sup>H]- is stored at 5°C in its original solvent and at its original concentration, the rate of decomposition is initially 1% per month from date of purification. Stability is nonlinear and not correlated to isotope half-life. Lot to lot variation may occur.

SPECIFIC ACTIVITY RANGE: 80-160 Ci/mmol (2960-5920 GBq/mmol)

**RADIOCHEMICAL PURITY:** This product was initially found to be greater than 95% when determined by the following method. The rate of decomposition can accelerate. It is advisable to check purity prior to use:

High pressure liquid chromatography on a Vydac C-18 peptide and protein column using the following mobile phase:

A: 0.2% trifluoroacetic acid B: acetonitrile,`

0% B to 50% B, linear gradient over 20 min.

**QUALITY CONTROL:** The radiochemical purity of nociceptin, [leucyl-3,4,5-<sup>3</sup>H]- is checked at appropriate intervals using the listed chromatography method.
