PACKAGING: 0.2 mCi/ml (7.4 MBq/ml) in ethanol: water: trifluoroacetic acid (50:50:0.1). Shipped in dry ice.

**STABILITY AND STORAGE RECOMMENDATIONS:** The stability of 5-carboxamidotryptamine trifluoroacetate, [³H]- is currently being evaluated. 5-carboxamidotryptamine trifluoroacetate, [³H]- should be stored at -20°C. Initial studies indicate that when 5-carboxamidotryptamine trifluoroacetate, [³H]- is stored in its original solvent and at its original concentration, the rate of decomposition is initially less than 3% per month from the date of purification. The rate of decomposition can accelerate. Stability is nonlinear and not correlated to isotope half-life. Lot to lot variation may occur.

SPECIFIC ACTIVITY RANGE: >20 Ci/mmol (>740 GBq/mmol)

**RADIOCHEMICAL PURITY:** This product was initially found to be greater than 97% when determined by the following method. It is advisable to check purity prior to use.

High pressure liquid chromatography on a SCX column using the following mobile phase: Potassium phosphate pH 5.3

**QUALITY CONTROL:** The radiochemical purity of 5-carboxamidotryptamine trifluoroacetate, [<sup>3</sup>H]- is checked at appropriate intervals using the above chromatography method.
