## LOT SPECIFIC INFORMATION

PACKAGING: 1.0 mCi/ml (37 MBq/ml) in aqueous solution, steri-packaged.

## STABILITY AND STORAGE RECOMMENDATIONS:

When hypoxanthine monohydrochloride,  $[^3H(G)]$ - is stored at 5°C in its original solvent and at its original concentration, the rate of decomposition is initially 2% per month from date of purification. Stability is nonlinear and not correlated to isotope half-life. Lot to lot variation may occur.

• A 70% ethanol solution is recommended as a solvent if the compound is to be stored longer than 3 months. The rate of decomposition in 70% ethanol solution at -20°C is initially less than 1% for 6 months. The purity should be checked prior to use and the material repurified if more than a few percent of impurities accumulate. Lot to lot variation may occur.

SPECIFIC ACTIVITY RANGE: >10 Ci/mmol (>370 GBg/mmol)

**RADIOCHEMICAL PURITY**: This product was initially found to be greater than 97% when determined by one or more of the following methods. The rate of decomposition can accelerate. It is advisable to check purity prior to use:

High pressure liquid chromatography on a C8 column using the following mobile phase: 1% triethyl ammonium acetate pH4.

**QUALITY CONTROL:** The radiochemical purity of hypoxanthine monohydrochloride, [<sup>3</sup>H(G)]- is checked at appropriate intervals using the listed chromatography method.
