PACKAGING: [125]-CGP 42112A is lyophilized from a solution containing 0.05M sodium phosphate, 0.18M sodium chloride, 1M glycine, 0.25% BSA, at pH 5.2. It is shipped ambient.

STABILITY AND STORAGE: The lyophilized [125]-CGP 42112A should be stored at 4°C or lower. Following reconstitution with distilled water to a concentration of approximately 25 µCi/ml on calibration date, aliquot and store at -20°C. Under these conditions the product is stable and usable for nine to ten weeks after fresh lot date.

SPECIFIC ACTIVITY: The initial specific activity of $[^{125}]$ -CGP 42112A is 2200 Ci/mmol (81 TBq/mmol), 1871 μ Ci/ μ g (69 MBq/ μ g).
