PACKAGING: [¹²⁵]-Fractalkine is in a solution containing 0.05M sodium acetate, 5% sucrose, 0.25% BSA, and a stabilizer, at pH 4.0-4.2. It is shipped on dry ice.

STABILITY AND STORAGE: [¹²⁵I]-Fractalkine should be stored at -20°C or lower. It should be aliquoted in appropriate volumes to avoid repeated freeze-thaw cycles. Under these conditions the product has been shown to be useful for at least three weeks after fresh lot date.

SPECIAL INFORMATION: [¹²⁵I]-Fractalkine sticks to glass. We recommend using silanized glass or plastic to minimize this problem.

SPECIFIC ACTIVITY: The initial specific activity of [¹²⁵]]-Fractalkine is 2200 Ci/mmol, (81 TBq/mmol), 259 µCi/µg (9.6 MBq/µg). Preparative HPLC is used to separate unlabeled Fractalkine from [¹²⁵I]-Fractalkine. Upon decay, [¹²⁵I]-Fractalkine undergoes decay catastrophe and the specific activity remains constant with time. However, it is not known what molecular fragments are generated from the decay event or what functional activity these fragments may have in different assays. References on ¹²⁵I decay and decay catastrophe of ¹²⁵I labeled compounds are available.¹⁻⁵.

RADIOCHEMICAL PURITY: Initially less than 5% unbound iodide as determined by thin layer chromatography.

PREPARATIVE PROCEDURE: Fractalkine CX3C (human, recombinant), obtained from PeproTech, Inc., Rocky Hill, NJ, is radioiodinated with no carrier added ¹²⁵I using a lactoperoxidase procedure and is purified by reversed phase HPLC. This method predominantly labels tyrosine residues.

AVAILABILITY: [¹²⁵I]-Fractalkine is routinely available from stock and is prepared fresh and packaged for shipment on the first Monday of each month. Please inquire for larger package sizes.

APPLICATIONS: Fractalkine is the first member of a new class of chemokines.^{6,7} [¹²⁵I]-Fractalkine binds with high affinity to the CX3CR1 receptor.⁸ [¹²⁵I]-Fractalkine will be useful for the localization and characterization of CXCR1 receptors.
