Kit specificity:


This assay kit contains antibodies which recognize the phospho-Tyr1289 epitope and a distal epitope on ErbB3, plus antibodies to detect Total ErbB3. The protein detected by this kit corresponds to UniProt ID P21860. ErbB3 is also known as Receptor tyrosine kinase erbB-3 and HER3. These antibodies recognize ErbB3 of human origin. Other species should be tested on a case-by-case basis.

Control lysate information:

Positive Control Lysate: Prepared from MCF7 cells, cultured to confluence in T175 flasks in 10% FBS containing media, then treated with 50 µM Pervanadate for 1 hour and lysed with 5 mL of Lysis Buffer.

Representative data

Data obtained with a 2-plate, 2-incubation protocol. MCF7 cells were seeded at 40K cells/well in a 96 well plate and incubated overnight. Cells were treated with Neuregulin-1 at the indicated concentrations for 15 minutes. Cells were lysed with Lysis Buffer and assayed for Phospho (Tyr1289) and Total ErbB3 in the same wells of an assay plate using the *SureFire Ultra Multiplex* kit. Equivalent to approximately 4,000 cells/datapoint.
