Kit specificity:


This assay kit contains antibodies which recognize distinct epitopes on NPM. The protein detected by this kit corresponds to UniProt ID P06748. NPM is also known as nucleophosmin and nucleolar phosphoprotein B23. These antibodies do not recognize NPM1-ALK. These antibodies recognize NPM of human origin. Other species should be tested on a case-by-case basis.

Control lysate information:


Positive Control Lysate: Prepared from HeLa cells, cultured to confluence in T175 flasks in 10% FBS containing media and lysed with 10 mL of Lysis Buffer.


Data obtained with a 2-plate, 2-incubation protocol. MCF7 cells were plated at 40K cells/well in a 96 well plate and incubated overnight. Cells were treated with Nocodazole at the indicated concentrations for 18 hours. Cells were lysed with Lysis Buffer and assayed separately for Phospho (Thr199) and Total NPM using respective SureFire Ultra kits. Equivalent to approximately 4,000 cells/datapoint.



Data obtained with a 2-plate, 2-incubation protocol. MCF7 cells were plated at 40K cells/well in a 96 well plate and incubated overnight. Cells were treated with Hydroxyurea at the indicated concentrations for 18 hours. Cells were lysed with Lysis Buffer and assayed separately for Phospho (Thr199) and Total NPM, using respective SureFire Ultra kits. Equivalent to approximately 4,000 cells/datapoint



Data was obtained by preparing dilutions of recombinant NPM and NPM1-ALK proteins in *SureFire Ultra* Lysis Buffer and assayed using the NPM Total *SureFire Ultra* kit.
