## Kit specificity:


This assay kit contains antibodies which recognize the phospho-Tyr759 epitope and a distal epitope on PLC $\gamma$ 2. The protein detected by this kit corresponds to UniProt ID P16885. These antibodies recognize PLC $\gamma$ 2 of human origin. Other species should be tested on a case-by-case basis.

## Control lysate information:


Positive Control Lysate: Prepared from THP-1 cells cultured in 10% FBS containing media. Cells were harvested and washed with HBSS + 0.1% BSA, adjusted to 4 x10 $^{\circ}$  cells/mL and then treated with 0.25 nM Pervanadate for 30 minutes. Cells were then lysed with the addition of 5X Lysis Buffer.


## Representative data

Data obtained with a 2-plate, 2-incubation protocol. THP-1 cells were seeded at 80K cells/well in a 96 well plate in HBSS + 0.1% BSA. Cells were treated with Pervanadate at the indicated concentrations for 30 minutes. Cells were lysed with 5X Lysis Buffer and assayed for Phospho (Tyr759) and Total PLC $\gamma$ 2 using respective *SureFire Ultra* kits. Equivalent to approximately 3,200 cells/datapoint.



Data obtained with a 2-plate, 2-incubation protocol. Ramos cells were harvested and seeded at 600K cells/well in a 96 well plate in HBSS + 0.1% BSA. Cells were treated with 25  $\mu$ g/mL of Anti IgM antibody for 0, 2, 5, 10, 20 & 30 minutes. Cells were then lysed with 5X Lysis buffer and assayed for Phospho (Tyr753, Tyr759, Tyr1197, Tyr1217) and Total PLC $\gamma$ 2 in separate wells of an assay plate with respective *SureFire Ultra* kits. Equivalent to approximately 24,000 cells/datapoint.
