

Positive Control Lysate: Prepared from RT-4 cells, cultured to confluence in T175 flasks in 10% FBS containing medium, then treated with 20 μ M Z-VAD, 20 ng/mL TNF α and 100 nM SM-164 for 4 hours and lysed with 5 mL of Lysis Buffer.

Data obtained with a 2-plate, 2-incubation protocol. RT-4 cells were seeded at 40K cells/well in a 96 well plate and incubated overnight. Cells were treated with TNF α at the indicated concentrations with 20 μ M Z-VAD and 50 nM SM-164 for 4 hours. Cells were lysed with Lysis Buffer and assayed separately for Phospho (Ser166) and Total RIPK1 using respective *SureFire Ultra* kits. Equivalent to approximately 4,000 cells/datapoint.
