Kit specificity:


This assay kit contains antibodies which recognize the phospho-Tyr145 epitope and a distal epitope on SLP-76. The protein detected by this kit corresponds to UniProt ID Q13094. SLP-76 is also known as Lymphocyte cytosolic protein 2 and SH2 domain-containing leukocyte protein of 76 kDa. These antibodies recognize SLP-76 of human origin. Other species should be tested on a case-by-case basis.

Control lysate information:

Positive Control Lysate: Prepared from Jurkat cells cultured in 10% FBS containing media. Cells were harvested and washed with HBSS + 0.1% BSA, adjusted to 4×10^6 cells/mL and then treated with 11 mM H₂O₂ and 50 nM Calyculin A for 10 minutes. Cells were then lysed with the addition of 5X Lysis Buffer.

Representative data

Data obtained with a 2-plate, 2-incubation protocol. Jurkat cells were seeded at 4 x 10⁶ cells/mL in HBSS + 0.1% BSA in a 96 well plate. Cells were treated with Pervanadate at the indicated concentrations for 30 minutes. Cells were lysed with 5X Lysis Buffer and assayed separately for Phospho (Tyr113, Tyr145, Ser376) and Total SLP-76 using respective *SureFire Ultra* kits. Equivalent to approximately 16,000 cells/datapoint.
