Kit specificity:


This assay kit contains antibodies which recognize distinct epitopes on signal transducer and activator of transcription 4 (STAT4). The protein detected by this kit corresponds to UniProt ID Q14765. These antibodies recognize STAT4 of human origin. Other species should be tested on a case-by-case basis.

Control lysate information:

Positive Control Lysate: Prepared from NK-92 cells, cultured to confluence in T175 flasks with MEM- α media containing 12.5% FBS,12.5% Horse Serum, 0.2 mM inositol, 0.1 mM 2-mercaptoethanol, 0.02 mM folic acid and 200 U/mL recombinant IL-2. Cells were then deprived of IL-2 for 18 hours, treated with 200 ng/mL IL-12 for 30 minutes and lysed at 3.2x10 6 cells/mL with Lysis Buffer.

Representative data:

Data obtained with a 2-plate, 2-incubation protocol. NK-92 cells were seeded in a T175 flask at 200K/mL in media deprived of IL-2 and incubated overnight. Cells were washed in HBSS, seeded at 3x106 cells/mL in a 96 well plate, then treated with IL-12 at the indicated concentrations for 30 minutes. Cells were lysed with Lysis Buffer at 1.2x106 cells/mL and assayed separately for Phospho (Tyr693) and Total STAT4 using respective *SureFire Ultra* kits. Equivalent to 2,400 cells/datapoint.
