
This assay kit contains antibodies which recognize distinct epitopes on CREB. The protein detected by this kit corresponds to UniProt ID P16220. CREB is also known as cAMP-responsive element-binding protein 1. These antibodies recognize CREB of human and mouse origin. Other species should be tested on a case-by-case basis.

Control lysate information:

Positive Control Lysate: Prepared from A-431 cells, cultured to confluence in T175 flasks in 10% FBS containing media, starved for 1 hour, then treated with 500 ng/mL EGF for 10 minutes and lysed with 8 mL of Lysis Buffer.

Representative data

Data obtained with a 2-plate, 2-incubation protocol. A-431 cells were seeded at 60K cells/well in a 96 well plate and incubated overnight. Cells were treated with UCN-01 at the indicated concentrations for 60 minutes and then treated with 200 ng/mL EGF for a further 10 minutes. Cells were lysed with Lysis Buffer and assayed separately for Phospho (Ser133) and Total CREB using respective *SureFire Ultra* kits. Equivalent to approximately 12,000 cells/datapoint.
