

Positive Control Lysate: Prepared from HeLa cells, cultured to confluence in T175 flasks in 10% FBS containing media, treated with 10µM MG132 and 2µg/mL PMA for 30 minutes and lysed with 5 mL of Lysis Buffer.

Data obtained with a 2-plate, 2-incubation protocol. HeLa cells were seeded at 40K cells/well in a 96 well plate and incubated overnight. Cells were treated with Anisomycin at the indicated concentrations in the presence of 10 μ M MG-132 for 30 minutes.
