LANCE *Ultra* assay (no wash steps).

Kit contents: The kit contains 4 components: LANCE *Ultra* Eu-labeled Anti- hTNFα Antibody stored in TSA,

0.1% BSA, LANCE *Ultra* ULight-labeled Anti- hTNFα Antibody stored in TSA, 0.1% BSA,

lyophilized hTNF α Analyte, and 10X LANCE Assay Buffer.

analyte is stable for at least 45 days when stored at -20°C.
