

## **Equipment Decontamination and Data Removal Certification**

Customers in the EU are advised to visit Revvity's public website and review <u>Revvity's Compliance to Environmental Directives</u> prior to discarding electrical and electronic equipment originally manufactured by Revvity (RVTY).

**INSTRUCTIONS:** This form must be used whenever customer-purchased/owned equipment (instruments, materials, parts, etc...) is shipped to RVTY or Revvity's business partners for repair, refurbishing, trade-in, replacement, recycling, disposal, or credit. Any equipment that has been used by a customer or located in an area where chemical, biological, or radioactive materials are/were handled must be assessed and, if necessary, decontaminated before it may be shipped from a customer's site. The customer must provide truthful, accurate information on this form and certify that the equipment is free of potentially hazardous contamination prior to shipping. Furthermore, all potentially sensitive/confidential data or information must be removed from all equipment prior to shipping or transfer.

Prior to shipping any **used** equipment to a destination facility, an authorized employee of the customer must complete/sign this form. RVTY field staff may complete/sign this form on behalf of the customer if the equipment is **new**, **unused**, and **contains no sensitive/confidential information**. A physical copy of this form shall be sent with the returned equipment (placed on the outside of the shipping container, in a "shipping docs" bag/envelope).

Certain destination facilities may have additional requirements for customers to submit this form for review and approval prior to shipping returned equipment. Contact RVTY Customer Care/Service for details.

Equipment with detectable radiation above background levels cannot be shipped/returned. Customers who wish to return, recycle, or dispose of equipment that contains or once-contained radioactive materials (i.e. sealed sources) must contact RVTY and request instructions for how to prepare the equipment/materials prior to shipment. <sup>3</sup>Equipment that may have come in contact with chemical warfare agents, dioxins, or explosive compounds cannot be shipped/returned.

## CERTIFICATION

I certify that to the best of my knowledge and belief that all the information on this form is correct and that the returned equipment described above is free of potentially hazardous biological, radiological, or chemical contamination that may harm human health or the environment. I accept responsibility for the decontamination and cleaning activities described on this form. I also understand that I must provide timely responses to reasonable requests from RVTY or Revvity's business partners for additional information for how returned equipment has been used and decontaminated. RVTY (including any of its business groups or business partners) has no obligation to handle, repair, service, recycle, or dispose any product unless adequate information is provided to ensure the safety of all personnel who may come in contact with the returned/shipped equipment.

Furthermore, I certify to the best of my knowledge and belief the returned equipment contains no potentially sensitive and/or confidential information (including but not limited to personal / customer data). I understand that RVTY (including any of its business groups or business partners) is not responsible for preventing unauthorized retrieval and misuse of sensitive or confidential information that is retained on or inside returned equipment or instrumentation.
