EXPERIMENTAL CONDITION

The batch to be controlled was compared to the reference batch currently in use, at increasing Anti Mouse-XL concentrations.

Anti Mouse-XL is lyophilized in PO4 buffer 100 mM pH7 ; 0.1% BSA ; Stabilizers.

All the reagents involved were diluted in PPI-Europium detection buffer (#61DB9RDF).

EXPERIMENTAL PROCEDURE

Reconstitute Anti Mouse-XL vial with 250 μ L H2O (if packaged under 5,000 tests or 1,000 tests) or 1 mL H2O (if packaged under 20,000 tests).

Reagents were dispensed as follows :


- 5 µL XL conjugate
- 10 µL PPI-Europium detection buffer (#61DB9RDF)
- 5 µL K conjugate

Incubation took place for 120 min at room temperature. The plate was read on Phera Star Plus under standard conditions.
