EXPERIMENTAL CONDITION

The batch to be controlled was compared to the reference batch currently in use, at increasing conjugate XL concentrations (IgG1-XL).

Pab Anti Mouse IgG-Tb is frozen in Hepes buffer 50 mM pH 7 ; 0.1% BSA.

All the reagents involved were diluted in PPI-Terbium detection buffer (#61DB10RDF).

EXPERIMENTAL PROCEDURE

Reagents were dispensed as follows :


- 5 µL Tb conjugate
- 10 µL PPI Terbium detection buffer
- 5 µL lgG1-XL

Incubation took place for 120 min at room temperature. The plate was read on Phera Star $\ensuremath{\mathbb{B}}$ under standard conditions.
