EXPERIMENTAL CONDITION

The batch to be controlled was compared to the reference batch currently in use, at increasing GST-D2 concentrations.

SA-K is lyophilized in PO4 buffer 100 mM pH7; 0.5% BSA; Stabilizers.

All the reagents involved were diluted in PPI-Europium detection buffer (#61DB9RDF).

EXPERIMENTAL PROCEDURE

Reconstitute SA-K vial with 250 μ L H2O (if packaged under 5,000 tests or 1,000 tests) or 1 mL H2O (if packaged under 20,000 tests).

Reagents were dispensed as follows:


- 5 μL Pept-GST-Biotin (5 μL diluent for negative control)
- 10 μL D2 conjugate
- 5 µL K conjugate

Incubation took place for 120 min at room temperature. The plate was read on Phera Star ${}^{\circledR}$ under standard conditions.
