### **EXPERIMENTAL CONDITION**

The batch to be controlled was compared to the reference batch currently in use, at increasing anti body concentrations (Ac Human-Biotin).

Anti hFc-d2 is frozen in PO4 buffer 100 mM pH7; 0.1% BSA.

All the reagents involved were diluted in PPI-Europium detection buffer (#61DB9RDF).

# EXPERIMENTAL PROCEDURE

Reagents were dispensed as follows:


- 5 μL Ac Human-Biotin
- 10 μL d2 conjugate
- 5 μL K conjugate

Incubation took place for 180 min at room temperature. The plate was read on Phera Star ® under standard conditions.
