EXPERIMENTAL CONDITION

The batch to be controlled was compared to the reference batch currently in use, at increasing anti body concentrations (Ac Human-Biotin).

Anti hFc-d2 is frozen in PO4 buffer 100 mM pH7; 0.1% BSA.

All the reagents involved were diluted in PPI-Europium detection buffer (#61DB9RDF).

EXPERIMENTAL PROCEDURE

Reagents were dispensed as follows :


- 5 µL Ac Human-Biotin
- 10 µL d2 conjugate
- 5 µL K conjugate

Incubation took place for 180 min at room temperature. The plate was read on Phera Star $\ensuremath{\mathbb{R}}$ under standard conditions.
